If your girlfriend/girlfriend/future husband/wife asks you to do the following or has exhibited this behavior, it is most likely a scam: Moves to private messaging site immediately after meeting you on Facebook or SnapChat or Instagram or any dating or social media. Often they delete the site you met them on right after they asked you to move to a more private messaging siteProfesses loves you very quickly and seem to quote poems and lyrics along with using their own kind of broken language, as they claim their love and affection quickly. They also showed concern for your health and love for your family. Promises marriage as soon as he/she gets to give up leave that they asked you to pay for. They ask for money (bank transfers) and Amazon, iTunes, Verizon, etc gift cards, for medicine, religious practices, and magazines to get home, internet access, complete job assignments, help sick friend, get him out of trouble, or something that sounds fishy. The military provides all soldier needs including food medical care and transportation for leave. Trust me, I lived it, you'll probably be fooled. I'm just trying to show you examples of you most likely to be deceived. Below is an email response I received after I sent a request to the American I discovered I was being tricked. I got this amazing response back with many useful links on how to find and report your scammer. And how to learn more about Romance Scams.Right now you can also copy the image he gave you and do a google image search and you will hopefully see the pictures of the real person he is pretending to be. This does not always work and takes some digging. If you find the real person you can directly message them and notify them that their image is being used for scamming. You have contacted an email monitored by the U.S. Army Criminal Investigation Command. Unfortunately, this is a common concern. We assure you that there is never any reason to send money to someone claiming to be a soldier online. If you've only spoken to this person online, it's likely they're not an American soldier at all. If this is a suspected cheat social media profile, we encourage you to report it to that platform as soon as possible. In most U.S. states, some individuals are required by law to report suspected abuse, neglect or exploitation of vulnerable adults to adult protection services. This is called u201cmandatory reporting.u201dSome states only require some professionals to report their concerns. No. Mandate reporters must identify themselves to the county's child welfare department when they do child abuse or neglect reports. However, people who are not legally authorized can make anonymous reports. Illinois (and all other states) requires a wide range of professionals to report suspected child abuse. These professionals and any other person required by law to report suspected abuse or called mandate reporters. You do not need to your name unless you are a mandate reporter and required to do so by the law of your State; But in all cases, mandated reporters contact information is confidential and protected by law.
